If you would like to take advantage of this Skip-A-Payment offer, please fill out the coupon below and indicate how you wish to pay your \$25 processing fee. **If your loan is paid by direct deposit or payroll deduction, please speak with a credit union representative to address the automatic payment.** The processing fee will not be applied to the principal or interest of your loan. Loans must have six (6) consecutive payments to qualify. If you have already had one (1) payment deferred in the last 12 months, you may not qualify for the Skip-a-Pay program.

**Please return the completed coupon before your scheduled payment due date to skip your December payment OR your January payment. Request must be received 5 business days prior to payment date.**

You may bring this coupon with your processing fee to Indiana State University Federal Credit Union, or simply place the completed form in an envelope and mail to 444 N. 3rd Street, Terre Haute, IN 47807.

By this Agreement, the terms of your loan will be modified. This is not a new loan, but only a modification of terms of your existing loan with us. Except as modified by this Agreement, all terms of the original loan, including our remedies upon default or late payment, remain unchanged. Interest will continue to accumulate on your loan during the month you modify your payment. You are responsible for suspending automatic payments you have initiated for the monthly payment modified. If you have loan protection (life, disability, or GAP) your loan may not be covered past the original loan term (maturity), and you may be responsible for any skipped payments.
